As lawful consideration for being permitted by L2W to participate in this activity and use its equipment, I hereby agree that I, my heirs, spouse, next of kin, distributees, guardians, legal representatives and assigns will not make a claim against, sue, attach the property of, or prosecute L2W, or any of its members, affiliates, officers, directors, agents, contractors or employees or any of them (the "Releasees"), for injury, death or damage resulting from my participating in the referenced activities, whether by reason of the negligence of Releasees or otherwise.

I acknowledge that I have been advised to wear a life vest and suitable clothing at all times. By my signature below, I acknowledge that I will inspect any equipment provided to me and will not use it unless I find it free of apparent defect, damage or items needing repair. I represent and warrant that I am experienced in water sports and I will not use any equipment provided unless I am familiar with it and I know how to operate it.

I am aware that there will be no lifeguards or other supervision provided during the trip. I expressly acknowledge and agree that all responsibility for the care and supervision of any minor children accompanying me on the trip will be my responsibility alone, and L2W expressly disclaims responsibility or liability for the care and safety of such minor children.

I expressly agree that the foregoing General **Release of Liability** and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
